Middleton Medical/Liability Waiver

The undersigned Middleton High School (a) participant and/or (b) if the participant is a minor or under the age of 18, his/her parent/guardian and/or (c) coach, assistant coach, trainer, spectator or their party (collectively "Applicant"), each in consideration of the use of the facilities at Middleton High School, Middleton, Idaho, whether located on the campus of Middleton High School or not, do by this document, release and forever discharge Middleton High School, and the Girls Soccer program, and their agents, employees, independent contractors and assigns (collectively "MHS") of and from any and all manner of action or actions, cause or causes of action, suits, injuries, or any other claims or demands rising out of our use of any facilities of MHS, or our participation in the MHS Girls Soccer program and camps. I hereby further agree to indemnify and hold harmless MHS of and from any and all manner of action or actions, cause or causes of action, suits, injuries, or any other claims or demands rising out of our use of any facilities of MHS, or our participation in the MHS Girls Soccer Camp, whether based on MHS's negligence or otherwise. I further agree: That the Guardian hereby acknowledges that the applicant has permission to participate in the MHS Girls Soccer Camp, on the campus of Middleton High School, or at such other locations as may be held. 2. That the Applicant and Guardian hereby acknowledge that Applicant is in good physical condition, sufficient to take part in the MHS Girls Soccer Camp. If the Applicant suffers from any physical or mental ailment, injuries, allergies or other physical or mental conditions of which MHS should be aware, Applicant and Guardian hereby agree to physically attach a signed exhibit to this agreement, advising MHS of such ailments. If no such signed document is attached to this agreement, Applicant and Guardian agree that no such ailments exist as to the Applicant. 3. That the Applicant and/or coach is covered by a medical insurance identified above, in an appropriate amount and with appropriate coverage for the Applicant's participation in the MHS Girls Soccer Camp or staff. 4. That in case of illness, accident, or injury to the Applicant, the Applicant and Guardian do hereby grant our consent and permission for MHS to obtain any medical care and treatment for the Applicant which MHS may deem necessary, including care and treatment by a physician, athletic trainer or hospital emergency facility. I further agree to assume full responsibility for any medical expenses incurred by the Applicant as a result of such illness or injury. 5. That I hereby acknowledge that the MHS Girls Soccer Camp staff holds the exclusive right to deny admission or to dismiss any Applicant from the MHS Girls Soccer Camp or staff, as MHS may in its discretion decide is necessary. In the event of such denial or dismissal, no refund shall be paid by MHS to Applicant, Guardian or Coach. 6. That MHS and the MHS Girls Soccer Camp staff may, without further consent, payment, permission or license, utilize any photographs, pictures, images, videos, and likeness of Applicant, whether analog or digital, for use by MHS for any lawful purpose. 7. That the terms of this agreement may not be altered or amended by any agent or employee of MHS, absent a written document, signed by all necessary parties, reflecting that alteration or amendment.
